
PROFESSIONAL ADJUDICATOR EXAMINATION

Requirements

In order to be eligible for the Adjudicator Examination it is required that the candidate:

1. Has successfully passed their Professional Licentiate Teaching Examination in the designated style (Ballroom, Latin, Rhythm, Smooth).
2. Is a fully paid-up member in good standing with the CDF and/or other CDF Recognized Association.

The Examination

There are TWO parts to the Adjudicator Examination.

Part 1 - "What you need to know about Adjudicating " session with an Examiner.

Part 2 - "Apprentice "Adjudicating

The Examination Process must be Fulfilled in the Following Order

1. **Application and payment (\$200) for the Adjudicator License must be received by the CDF Admin Sec. prior to starting the process.** The Admin Sec. will then make arrangements with an Examiner for Part 1 of the Exam. This portion of the Exam must be done with an Examiner at a separate time from the Candidates Technical Teaching Exam.
2. **Once the session on "What You Need to Know About Adjudicating" (Part 1) is completed,** the Candidate can make an application to the CDF Admin Secretary requesting arrangement of Apprentice Judging (Part 2). The CDF Admin will contact the Competition Organizer for permission to have an Apprentice Adjudicator work at the event. The Event Chairperson will decide what sessions an Apprentice will adjudicate, giving the Apprentice the most valuable experiences.
3. **A minimum of three events are required for Apprentice Judging. Each event will have the Apprentice work three (3) full sessions decided on by the Chairperson of the event.**

An Adjudicator License Allows the Following

- Once passing both Parts, a Licentiate is permitted to adjudicate all Levels of competition.
- An adjudicator who is still competing in Professional Competitions and Championships (not applicable to Pro-Am) is not permitted to adjudicate a Professional Competition.
- A newly licensed Adjudicator is only permitted to adjudicate Professional Competitions after One (1) year has lapsed from date of receiving the CDF Adjudicator License.

Before an Adjudicator License can be approved, the completed forms, signed by the Examiner and by Chairpersons of Apprentice Judged Events must be submitted to the CDF Admin Sec.
